City of Raleigh Stormwater, Kris Bass Engineering, NCSU College of Natural Resources and WRRI have been awarded an EPA 319 grant to install green stormwater infrastructure in Biltmore Hills Park. Ever Wonder How Much Trash Ends Up in Streams?

The “Carolina Madtom” sculpture, located on Peterson Street at Walnut Creek Wetland Park, is made from 800 pounds of trash found in Walnut Creek in Raleigh and surrounding areas. This piece brings awareness to the impact we have on streams and wildlife, like the Carolina

Madtom, a rare NC catfish. The piece was created by artists Jaclyn Bowie, Nyssa Collins, and Anna Wagner in collaboration with Walnut Creek Wetland Park, the City of Raleigh’s Stormwater Management Division, and Conservation Corps North Carolina volunteers. 
